

Sea Angling Diary Project 2020 – Prize Draws Terms and Conditions

5. The competition is open to all UK residents aged 18 years or older and by entering the competition you confirm that you are 18 years or older.

Sign Up Draw

6. All those signing up to participate in the Sea Angling Diary for 2020 will qualify for the draw. This includes existing participants who continue participation in 2020.
7. The closing date for entries is January 31st 2020.
8. The winner will be selected at random by Substance no later than the 15th February 2020. The winner will be notified by email within 28 working days of the competition closing date.
9. If a winner does not claim the prize within 28 days of being notified, or if a winner is not available to take up the prize, Substance reserves the right to award the prize to another entrant without liability to the winner.
10. The prize will be sent to the winner at the expense of Substance.
