

Sea Angling Diary Project 2022 – Prize Draw Terms and Conditions

2. The Terms and Conditions supersede any previous Terms and Conditions set.
3. By entering the competition, you agree to be bound by these Terms and Conditions.
4. No donation to Substance is necessary in order to enter the competition or be considered for the prize.
5. The competition is open to all UK residents aged 18 years or older and by entering the competition you confirm that you are 18 years or older.

Sign Up Draw

6. All those signing up to participate in the Sea Angling Diary for 2022 will qualify for the draw.
7. The closing date for entries is January 31st 2022.
8. The winner will be selected at random by Substance no later than the 15th February 2022. The winner will be notified by email within 28 working days of the competition closing date.
9. If a winner does not claim the prize within 28 days of being notified, or if a winner is not available to take up the prize, Substance reserves the right to award the prize to another entrant without liability to the winner.
10. The prize will be sent to the winner at the expense of Substance.
11. The draw is for:

 - TWO X **£50 shopping vouchers** for Social Supermarket (subject to Social Supermarket conditions of use)

Monthly Draws

12. All those completing their data entry each month will qualify for a monthly prize draw.
